 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- This privacy policy applies only to the actions of Muumaa Model Management Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Muumaa Model Management Ltd is the "data controller". This means that Muumaa Model Management Ltd determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:
 - a. Name, date of birth, geographical location, gender, body measurements and general aesthetic;

How we collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you;
 - b. your application form/CV
 - c. when you contact us via email or telephone;
 - d. providers of background checks;
 - e. notes and records kept for the duration of your engagement with us as a Model;
 - f. from our clients (including reviews/feedback and images and photographs); and
 - g. publicly available sources such as magazines, press articles, and social media

Data that is given to us by you

- 7. Muumaa Model Management Ltd will collect your Data in a number of ways, for example:
 - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. when you register with us and set up an account to receive our products/services;
 - c. when you complete surveys that we use for research purposes (although you are not obliged to respond to them);
 - d. when you elect to receive marketing communications from us;
 - e. when you use our services;

in each case, in accordance with this privacy policy.

Data that is collected automatically

- 9. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

 - b. we store your Data on secure servers.

c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

- 18. Data retention

Your rights

- 21. You have the following rights in relation to your Data:
